First Manitowoc Bancorp, Inc. (OTCBB: FMWC.OB), parent company of Bank First National, announced that its Board of Directors approved a quarterly cash dividend of \$0.105 per common share payable on December 11, 2009, to shareholders of record November 30, 2009. The dividend is unchanged from the prior quarterly dividend of \$0.105 per share.

First Manitowoc Bancorp, Inc. provides financial services through its sole subsidiary, Bank First National, a national banking association incorporated in 1894. The Bank is an independent community bank with 15 banking locations in Manitowoc, Brown, Calumet, and Sheboygan counties. The Bank has grown through both acquisitions and de novo branch expansion. The Bank offers loan, deposit, investment advisory and trust products at each of its banking offices. Insurance products are available through its wholly owned subsidiary, The Vincent Group, Inc. and asset management services are available through its wholly owned subsidiary, The George V. Reis Investment Group, Inc. The Bank employs approximately 243 full time equivalent staff and has assets of \$787 million as of October 31, 2009.
