Bank First Decreases Prime Rate

MANITOWOC, Wis, September 23, 2019 -- Bank First (NASDAQ: [BFC](#)), the subsidiary of Bank First Corporation, announced today it has decreased the bank's prime rate from 5.25 percent to 5.00 percent, effective September 23, 2019.
