Bank First Decreases Prime Rate

MANITOWOC, Wis, November 4, 2019 -- Bank First (NASDAQ: [BFC](#)), the subsidiary of Bank First Corporation, announced today it has decreased the bank's prime rate from 5.00 percent to 4.75 percent, effective November 4, 2019.
